TODAY IT IS THE RNA

TOMORROW IT COULD BE YOU

On Friday September 3, 1971, scores of heavily armed Detroit Police entered the office of the Republic of New Africa, 19121 Pinehurst, in a residential community, and handcuffed and arrested 2 children, age 13 and 14.

A gun was allegedly found that police say was used in the killing of Black Police Officer Alonzo Marshall on Gratiot. Several RNA citizens have been charged with this murder including a 15 year old whose rights have obviously been violated since the news media published his name. Prosecutor Cahalan is attempting to have ~~them~~ tried as an adult.

The RNA has been the victim of many police attacks. Detroiters well remember the infamous New Bethel incident in which Police fired hundreds of rounds of ammunition into the Rev. C.L. Franklin's church disregarding the lives and safety of 143 men, women, and children. Recorder's Court Judge Crockett upheld the Constitutional rights of those arrested in that incident. Wide support for his action developed among the people and a frame-up was averted.

On August 18, 1971, the RNA Government House was attacked in Jackson, Mississippi in a police raid led by F.B.I. agents obviously under the orders of J. Edgar Hoover and U.S. Attorney Mitchell. During the attack a Police officer was killed. Eleven citizens of the RNA have been charged with murder and treason to the state of Mississippi.

The attack on the RNA in Mississippi and Detroit is a part of the racist attack on Black People which threatens the constitutional rights of all Americans.

The murder of Fred Hampton, George Jackson, and many other Panthers, the attempted frame-up of dozens of Panthers in lengthy costly trials in Detroit and other cities, the Reagan-Nixon plan to railroad Angela Davis to the gas chamber, and the assault on the Republic of New Africa in Mississippi and Detroit are all a part of the same plan to undermine the rights of all Americans.

Now is the time to speak out--today it is the RNA, tomorrow it could be you. If you protest against racism and the local bigots don't like it; if you speak out against the Viet Nam War or the wage freeze and tricky Dick Nixon doesn't like it -- you could be the victim of a Police frame-up.

Call Wayne County Prosecutor Cahalan (phone) 7245177, demand that he drop the charges against the local citizens of the RNA. Write to the Governor of Mississippi. Demand that the charges against the RNA defendants be dropped. Get your church, local union, community organization to speak out for justice now.

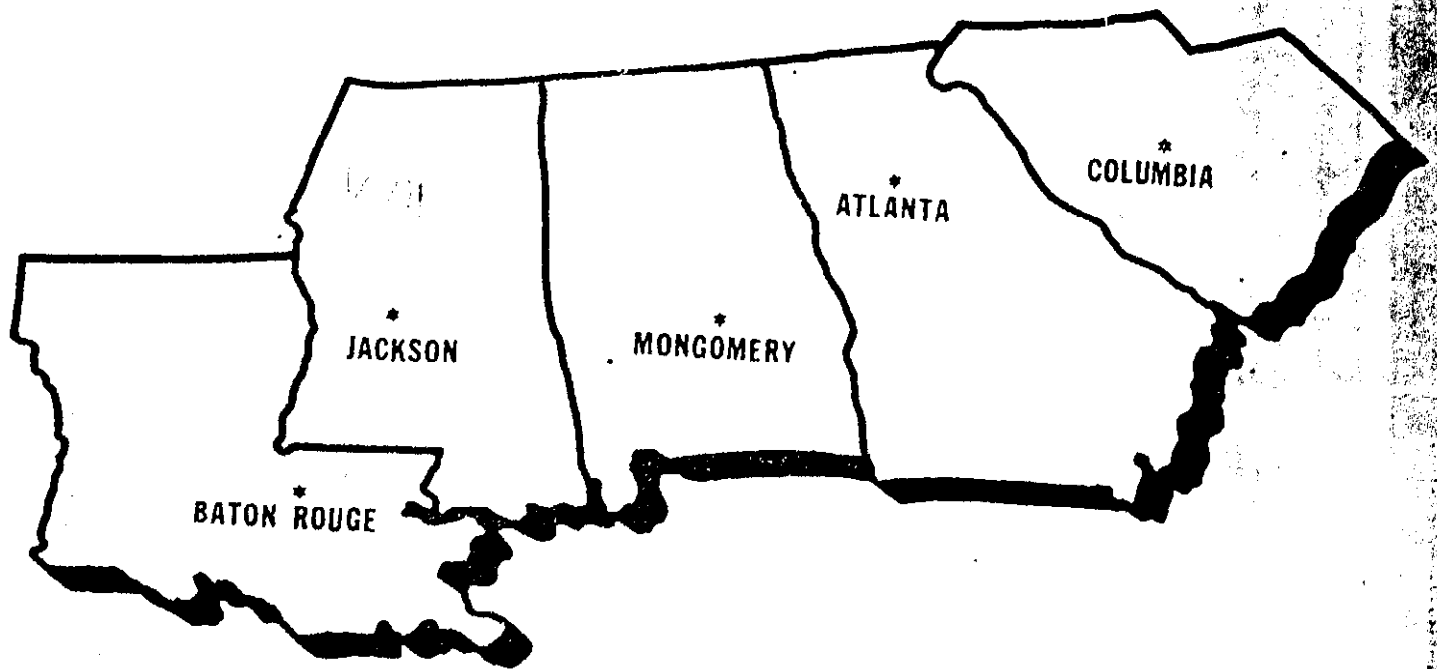
1. We are urging the Vietnamese to observe a Cease-Fire with Black Troops.

----- CONSPIRACY

LACKING REAL EVIDENCE, THE PROSECUTOR CONVENED HIS "SECRET CITIZENS' GRAND JURY", TO GET ILLEGAL INDICTMENTS AGAINST THE "15" YOUTHS ON TRUMPED-UP CHARGES.

CONSPIRACY IS A TRUMPED-UP CHARGE, ALMOST IMPOSSIBLE TO DEFEND.

CONSPIRACY CHARGE USED TO GET A CONVICTION WHEN LACKING ACTUAL EVIDENCE.

CONSPIRACY IS THE SAME CHARGE THAT THE ESTABLISHMENT IS TRYING TO "RAILROAD" ANGIE DAVIS TO JAIL ON.

"FAIR AND IMPARTIAL TRIAL" WHEN:

1. BEING BLACK, double standards of justice.
 2. BEING ALLEGED N.C.C.F. MEMBERS, POLITICAL overtones & pressures.
 3. BEING POOR, LACK money for defense.
 4. BEING "RAILROADED" denied public "show cause hearing" by the prosecutor.
 5. BEING ILLEGALLY INDICTED BY the prosecutor's CITIZENS' GRAND JURY, WITHOUT REPRESENTATION.
 6. BEING PRE-TRIED, by the prosecutor & bias daily news-media.
 7. BEING PRE-JUDGED, by many people exposed to only hostile reporting by the news-media.
 8. BEING PRE-SENTENCED, in jail since Oct. 1970. but suppose to be "innocent until proven guilty."
 9. BEING THE TARGET OF A CONSPIRACY, to eliminate militants Blacks, but let the KKK exist.
 10. BEING DETAINED AS POLITICAL PRISONERS, to maintain the status quo.
 11. BEING JAILED ILLEGALLY, defendants can not prepare proper defense.
 12. BEING DENIED TRANSCRIPTS AND EVIDENCE, by the prosecutor, needed to prepare proper defense.
 13. BEING ILLEGALLY QUESTIONED WHILE IN JAIL by the prosecutor's office, WITHOUT DEFENDANT ATTORNEYS.

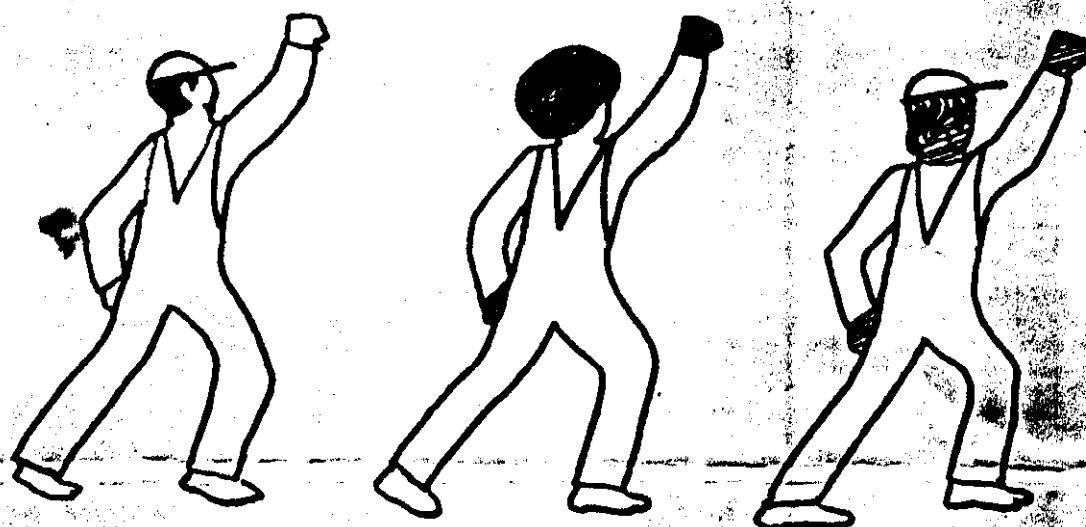

"COMING FROM A HARD BLACK THING"

Defense Minister Of Black Panthers Shot

HUEY NEWTON, DEFENSE MINISTER OF THE MILITANT BLACK PANTHER PARTY FOR SELF-DEFENSE, LIES IN THE HOSPITAL AT SAN QUENTIN STATE PRISON WITH A GUNSHOT WOUND IN THE STOMACH. HE WAS SHOT BY AN OAKLAND, CALIFORNIA COP. AN OAKLAND COP IS DEAD AND BURIED, AND ANOTHER IS IN A HOSPITAL WITH THREE BULLET WOUNDS IN HIS BODY. HUEY HAS BEEN CHARGED WITH THE MURDER OF THE DEAD COP, AND THE SHOOTING OF THE SECOND.

HUEY NEWTON'S CASE IS SIMILAR TO THE BARBEE CASE IN DAYTON WITH ONE IMPORTANT DIFFERENCE. HUEY IS ALIVE AND THE COP IS DEAD.

THE BROTHERS IN CALIFORNIA ARE SUPPORTING HUEY NEWTON. THEY ARE RAISING MONEY FOR A HUEY NEWTON DEFENSE FUND, JUST AS WE ARE RAISING MONEY FOR THE WILLIE DIXON DEFENSE FUND.

LET US MAKE ONE THING CRYSTAL CLEAR. WE DO NOT CLAIM THE RIGHT OF AIMLESS VIOLENCE. WE ARE NOT OUT TO KILL WHITE PEOPLE. ON THE CONTRARY, IT IS THE COPS WHO HAVE BEEN BATHING BLACK PEOPLE IN BLOOD, AND WHO ARE DETERMINED TO KILL OFF BLACK PEOPLE.

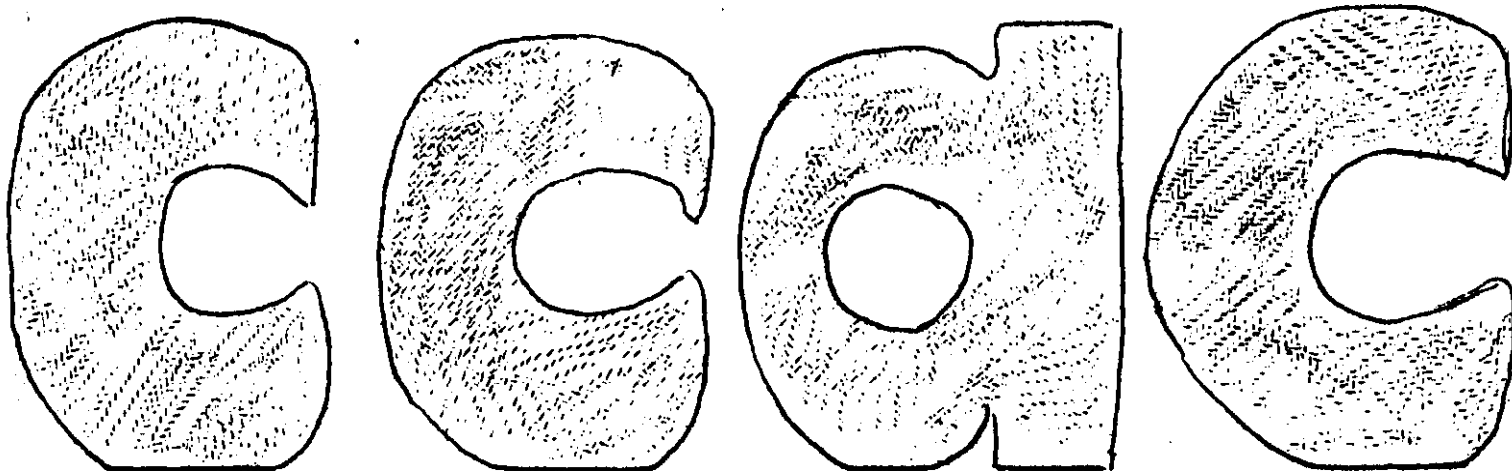
BUT BLACK PEOPLE; THIS DAY, THIS TIME; SAY, "HALT, IN THE NAME OF HUMANITY!" YOU SHALL MAKE NO MORE WAR ON UNARMED PEOPLE! YOU WILL NOT KILL ANOTHER BLACK PERSON AND WALK THE STREETS OF THE BLACK COMMUNITY TO GLOAT ABOUT IT. BLACK PEOPLE ARE GOING TO DEFEND THEMSELVES FROM NOW ON!"

IN THE SPIRIT OF BROTHER MALCOLM AND BROTHER HUEY, WE WANT TO MAKE IT CLEAR TO EVERY RACIST COP---"THE BLACK MAN'S LIFE IS PRECIOUS. HE IS GOING TO DEFEND HIS LIFE BY ANY MEANS NECESSARY".

CHE GUEVARA, THE CUBAN GUERRILLA LEADER, WHO WAS RECENTLY KILLED IN BOLIVIA, HAD THIS TO SAY ON THE SUBJECT OF DEATH AND VIOLENCE:

"Wherever death may surprise us, it will be welcome provided that this, our battle cry, reach some receptive ear, that another hand stretch out to take up weapons, and that other men come forward to intone our funeral dirge with the staccato of machine guns and the cries of battle and victory."

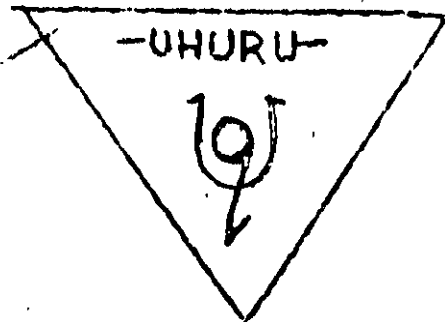

THE FLAG OF OUR NATION

We have chosen for our national flag the Green, Red and Black used by Africans and Black Nationalists historically. In our flag Black is on the bottom. This Black represents us (all Black people). It is at the bottom because that is where we are now in the world. We are still slaves in this and other countries.

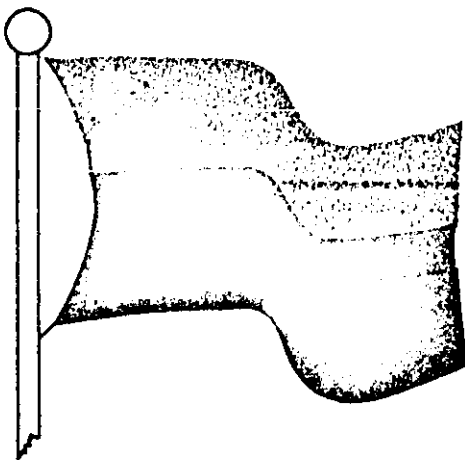
Above the Black stripe and in the middle of the Flag is the Red stripe. The Red stripe is half the size of the Green and Black stripes. As history teaches us, blood is shed to win and to secure Freedom; however, we plan to shed as little Black blood as possible.

The Green represents the land of our nation. It's position on top of the Black and Red demonstrates our recognition of land as the most important single element for our Freedom and Independence.

When we have won our sovereignty beyond any doubts, we can then turn our flag to its proper position. Our flag will then have the Black on top, for we will have overcome those evil forces in nature and will have arrived at our place in destiny.

NOTE: All flags not having the Green, Red and Black order are still to be recognized as official until March 31, 1972.

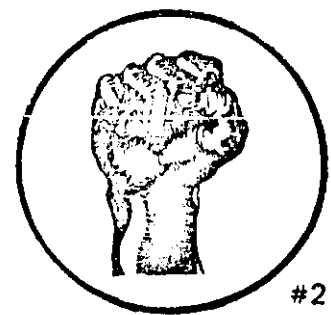

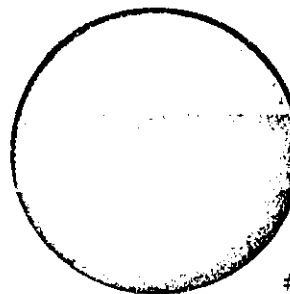
